20 000 x 3000 in thicknesses up to 80mm in S355 and 100mm in stainless on our new 20kw fibre laser (should be one of the biggest in Africa).  
2 off 6000 x 2000 in thicknesses up to 16mm in S355 and 10mm in stainless.**

**We also house 2 hi-definition plasma machines with beds of 13000 x 3000 capable of cutting accurately up to 50mm thick (both carbon & Stainless)**

**Completing our cutting range is our oxyfuel profile cutting machine and our 'standalone' service centre – the Peddinghaus machine capable of high-def plasma cutting, punching, and drilling in one process.**

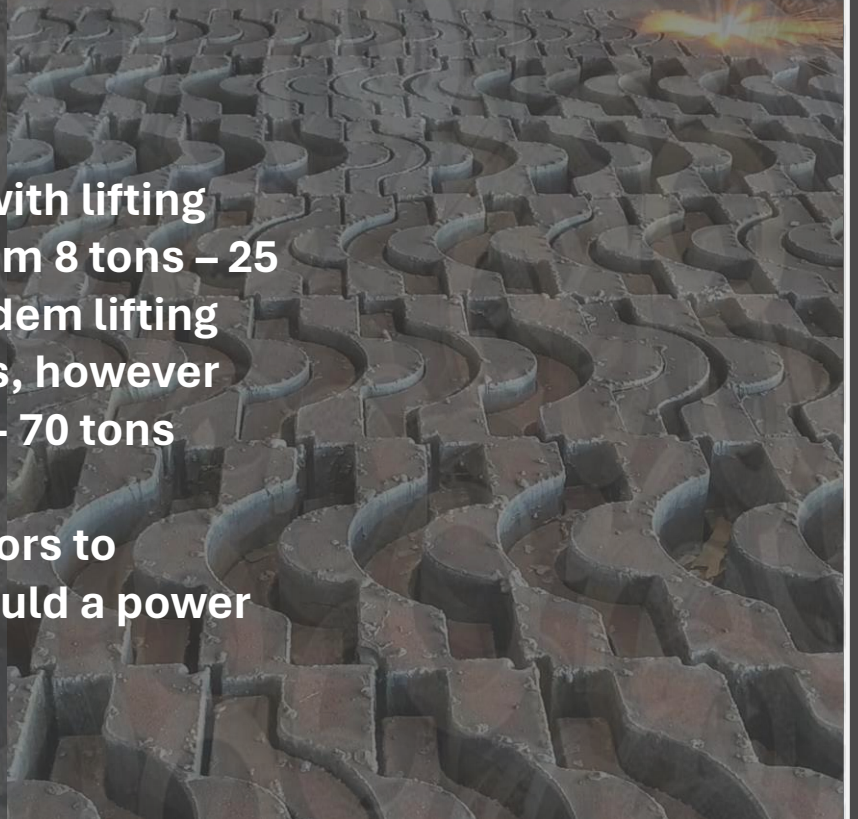
**We have a 350ton ermaksen cnc bending machine with a huge range of tooling.**

**We are capable in detailing S355, Stainless steel and all plate work & structural steel.**

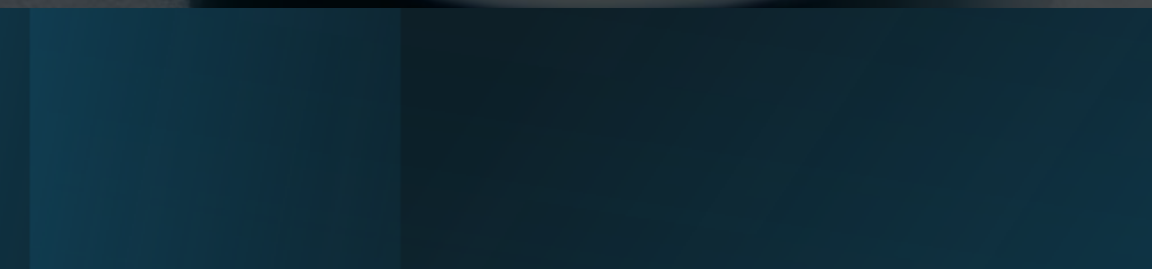

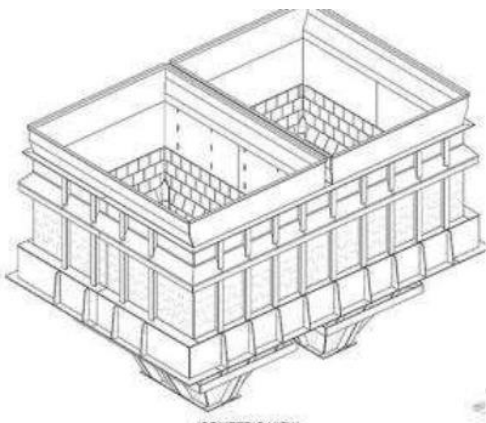

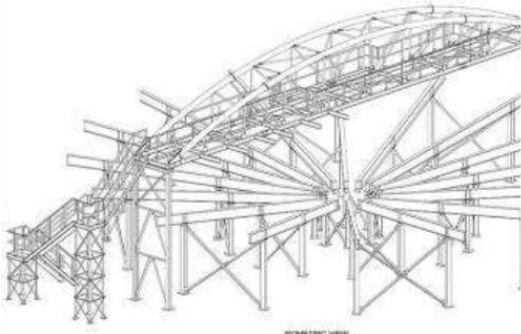
